OFFICE ORDER NO. 196/2017

The President is pleased to promote Shri Ramavath Srinivasa Naik, an officer of the Indian Revenue Service (Customs and Central Excise), to the grade of Commissioner of Customs, GST and Central Excise in the pay scale of Rs. 37400-67000/- with grade pay of Rs.10000/- (pre-revised) on provisional and ad-hoc basis, notionally w.e.f. 06th January, 2015 and initially for a period of one year w.e.f. the date of assumption of charge of the post and until further orders, subject to the outcome of the Writ Petition No. WPCT 262/2016 pending in the High Court of Kolkata.

The promotion of Shri Ramavath Srinivasa Naik to the grade of Commissioner of Customs, GST and Central Excise is purely on ad-hoc basis and subject to the orders for regular promotion and also subject to the outcome of pending court cases or any other related issue. He will have no right to claim for regular promotion on the basis of this ad-hoc promotion.

Consequent upon promotion to the grade of Commissioner of Customs, GST and Central Excise and keeping in view the administrative exigencies, the following officers are hereby ordered, with the approval of the competent authority, to be posted in the grade of Commissioner of Customs and GST and Central Excise to the post mentioned against each with immediate effect and until further orders:
