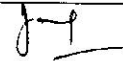
4. The promotion of the above officers to the grade of Joint Commissioner is subject to the outcome of related court cases, if any.

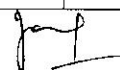

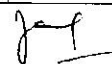

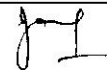

7. All the officers mentioned above shall be relieved immediately and they must join at their new place of posting **on or after 01st July, 2017 but not later than 07th July, 2017**, under intimation to the Board. 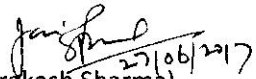
8. Out of the 122 officers promoted to the grade of Joint Commissioner of Customs & Central Excise, the posting of 4 officers, who are presently on deputation, will be decided after they repatriate to the cadre and report to the Board for joining in the promotion post.

9. Keeping in view the roll out of GST from 01st July, 2017, the officers have been posted in the CGST & CX Zones only. The respective Committees of Chief Commissioners of Customs / CGST & CX Zones should immediately meet and decide deployment of the above officers and ensure posting of sufficient number of officers to Customs Zones.

10. The Chief Commissioners/Directors General, Principal Commissioners/ Principal Additional Director Generals, CBEC concerned shall ensure that if any of the officers whose name has figured in para 1 of this order is under suspension or facing any charge sheet or prosecution, he/she should not be relieved / allowed to assume charge of the post of Joint Commissioner and this fact should be reported to the Board immediately. Further, if any of the officers figured in para 1 of this order is undergoing any penalty, he/she should be relieved/allowed to assume the charge of the post of Joint Commissioner only after the expiry of the currency of the penalty period. This fact may also be reported to the Board.

11. The Chief Commissioners/Directors General concerned shall send compliance reports regarding relieving and joining of the above officers to the Board **[with a copy endorsed to ADG (HRM-II), DGHRD]** by **10th July, 2017** positively.

12. All representations received from the officers for postings on promotion to the grade of Joint Commissioner of Customs and Central Excise stand disposed of.
